## Veterans Assistance Commission- Paul Havermale

Director Havermale stated that since January 2, they have seen 118 clients. Of those, 45 are seeking VA services.

Through the efforts of the VAC, \$200,000 new VA dollars have been brought into the County,

They have hired an Administrative Assistant.

They are trending ahead on their budget. They have approximately 70% of their budget dollars remaining.

Emily is now fully accredited with VA access.

## Emergency Management/Ambulance-Director John Simon

Director Simon reports that they are communicating with the Army Corps of Engineers to be a staging location for flood fighting equipment. It would be stored at the EMS/EMA warehouse.

The Ambulance Service is working on a Mass Casualty Grant.

The Tactical Medic program is complete. They have Tactical Medics trained and ready to support the Sheriff and Quincy Police as needed.
