A motion to approve the minutes from July 9, 2024, as written by Mrs. Bockhold and seconded by Mr. McCoy. The minutes were approved unanimously as printed.

The committee reviewed the bills, and all appeared to be in order.

Dr. Reich noted that the new attorney in the State's Attorney's Office, Erin, will be assisting the process of solar and wind farms.

Dr. Reich presented Resolution Number 2024-08-121-024 to Establish a New Permanent Polling Location for Keen Township. Mr. Niekamp explained that the polling location would be moved across the street to the Fire Department's building which has a public access area.
