FIRST AMENDED PROTECTIVE COVENANTS

KNOW ALL MEN BY THESE PRESENTS, that the undersigned representing a majority of the current owners of the lots contained in Bradmoor subdivision do hereby amend the original protective covenants as recorded in book 75 of miscellaneous at page 252 and 253 in the Recorder's office of Adams County, Illinois, in the following manner:

1. The paragraph which currently reads as follows:

"No structure shall be erected, altered, placed, or permitted to remain on any residential building plot other than one detached single-family dwelling not to exceed two stories in height and a private garage for not more than two cars."

Is hereby amended to read as follows:

"No structure shall be erected, altered, placed, or permitted to remain on any residential building plot other than one detached single-family dwelling not to exceed two stories in height and a private garage for not more than two cars and one lawn storage building which shall not contain more than two -hundred and fifty (250) square feet."
