**AMENDMENT TO RESTRICTIVE COVENANTS
OF HOOK'N QUARTER SUBDIVISION**

The undersigned, representing a majority of the owners of lots in the Subdivision, by this document do hereby amend the Restrictive Covenants of the Subdivision in the following respects only, to-wit:

1. The Restrictive Covenants run with the land and have no expiration date.

2. The Restrictive Covenants may be amended at any time by written agreement of two-thirds of the Lot owners which is then recorded in the Adams County Recorder's Office. Each lot will have one vote regardless of the number of owners of such lot, except as hereafter provided. If there are more than two owners of a lot, a majority of the owners will determine the vote for that lot. If there are two owners of a lot and they are unable to agree, each owner may cast one-half vote.

Except as modified by this Amendment, the current Restrictive Covenants, as previously amended, are restated and remain in full force and effect.
