AMENDMENT TO PROTECTIVE COVENANTS

KNOW ALL MEN BY THESE PRESENTS that the undersigned, being a majority of the owners of that real estate known as all of the Lots of Spring Lake Estates, a subdivision of a part of the Northeast, Northwest and Southeast Quarters of Section Fourteen (14) in Township One (1) South of the Base Line and in Range Nine (9) West of the Fourth Principal Meridian, Adams County, Illinois,

do hereby amend the Protective Covenants recorded in Book 84 of Miscellaneous Records at page 63 by substituting the following for the original paragraphs:

A - 1. LAND USE AND BUILDING TYPE is hereby amended to read as follows:

No lot shall be used except for residential purposes. No building shall be erected, altered, placed or permitted to remain on any lot other than one detached single family dwelling not to exceed two and one-half stories in height and a private garage, for a minimum of two cars. Lots may not be redivided except to increase the size of adjoining lots. If resubdivided, the appropriate adjoining lot combined with the redivided lot shall thereafter be treated as a single lot with side yard and other setback lines considered appropriately altered. No lot shall be divided to create any additional building lot or lots.

All other parts of the previously cited Protective Covenants shall remain in full force and effect.
