## SECOND AMENDMENT TO DECLARATION OF

# CONDOMINIUM OF TRINITY LAKES CONDOMINIUMS

WHEREAS, the Developer now desires to annex and add to said Parcel and Property and to submit to the provisions of the Act and the Declaration additional portions of the Additional Land (the "Additional Property") which Additional Property is legally described in Exhibit A attached hereto.

NOW, THEREFORE, the Developer does hereby amend the Declaration as follows:

- 1. The Additional Property is hereby annexed to the Parcel and Property as defined in the Declaration, and is hereby submitted to the provisions of the Act as part of the Condominium in accordance with, and to be governed in all other respects by, the terms and provisions of the Declaration.
- 2. Exhibit A of the Declaration, is hereby deleted in its entirety and replaced by the Exhibit A attached hereto.
- 3. Exhibit A-1 of the Declaration, is hereby deleted in its entirety and replaced by the Exhibit A-1 attached hereto.
- 4. Exhibit B of the Declaration, is hereby deleted in its entirety and replaced by the Exhibit B attached hereto.
- 5. The Additional Common Elements annexed by this instrument are hereby granted and conveyed to the grantees of all Units, including the grantees of the Units heretofore conveyed, all as set forth in the Declaration.
- 6. Except as expressly modified herein, the Declaration shall remain in full force and effect in accordance with its terms.
