## AMENDMENT TO RESTRICTIVE COVENANTS

The undersigned enter into this Amendment to Restrictive Covenants (hereinafter "Amendment") this 16 day of April, 2014.

WHEREAS, Lots 1 through 18 of Wild Horse Estates, a subdivision of part of Lots Ten (10) and Eleven (11) in B.I. Chatten's Subdivision of the Northwest Quarter of Section Eighteen (18), in Township Two (2) South of the Base Line, in Range Eight (8) West of the Fourth Principal Meridian, in Adams County, Illinois, which is sometimes referred to herein as the "Subdivision", said Lots having the following P.I.N. numbers:

WHEREAS, the undersigned warrant that they are vested with title in their hereinafter described respective Lots in the Subdivision and desire to amend the Restrictive Covenants, recorded in the Offices of the County Recorder of Adams County, Illinois in book 91 of Miscellaneous Records at page 1238, as Document No. 041561 on March 7, 1996 as amended by the "Amendment To Restrictive Covenants," recorded in offices of the Adams County Recorder, Adams County, Illinois on June 19, 2012, as Document No. 2012R-06324 (hereinafter collectively referred to as the "Restrictive Covenants") as set out below;

NOW, WHEREFORE, for good and valuable consideration, the undersigned agree to amend the Restrictive Covenants as follows:

- 1. Section 1. of the Restrictive Covenants, "Land Use and Building Type" shall be amended in that in addition to the detached single-family dwelling currently located on Lots 1 and 2 of the Subdivision, the title of which is vested in Jeremy Allen and Tawny Allen, husband and wife, a pool house building detached from said single family dwelling, having dimensions not to exceed twenty (20) feet by forty-five (45) feet, may be constructed on said Lots 1 and 2, west of said single-family dwelling.
- 2. To the extent this Amendment conflicts with the Restrictive Covenants, the terms of this Amendment shall control. To the extent the terms of this Amendment and the Restrictive Covenants do not conflict, the Restrictive Covenants shall remain in full force and effect. This Amendment shall be for the benefit of Lots 1 and 2 and be binding upon all of the Lots which are a part of the Subdivision from time to time and, as such, shall be deemed to be covenants running with the land. This Amendment shall be binding upon and for the benefit of the parties hereto and their heirs, legal representatives, successors and assigns. The recital paragraphs contained in this Amendment shall be incorporated into and made a part of this Amendment. This Amendment may be executed in one or more counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument.
