The committee reviewed the minutes from the previous meeting. Theresa Bockhold moved to approve them as written, seconded by Todd Duesterhaus. The minutes were approved.

Ryan Niekamp spoke regarding senate bill number 825 it was passed by the house and senate and if the governor signs it will push reapportionment back to November and December instead of June and July which will push back the primary elections from March to the end of June (June 28th) next year. Petition filings will be pushed back to January and it will affect all offices. It is believed the governor will sign this bill and it will make the general election day in November a state holiday.

Reappointment of Phil Doane to the Liberty Fire Protection District for a three-year term to expire in May of 2024. Theresa Bockhold moved to approve, seconded by Todd Duesterhaus. The committee approved the reappointment unanimously.
