  - a. Resolution Number 2022-04-001-018 Village of Mendon Water Improvement Infrastructure.
    - i. The Executive Committee will recommend \$130,778.00 of matching funds. Matt Obert makes a motion to proceed with this amount for this project. Bob Reich seconded the motion. Motion passed.
  - b. Resolution Number 2022-04-001-019 Ameren Overhead Power Line
    - i. The Executive Committee will recommend \$200,000.00 to the full County Board. The total cost of this project is 1.5 million. The overhead lines are 96 years old and need to be replaced. Ameren is contributing \$700,000, the City of Quincy, \$53,000, and Jil Tracy's office through grants of \$353,000. This is considered an infrastructure project. No action taken on behalf of the Finance Committee.
  - c. Resolution Number 2022-04-001-020 Recovery Anonymous
    - i. Executive Committee will be recommending \$2,500 to Recovery Anonymous for the false hope of receiving \$200,000 for their project. Recovery Anonymous has invoiced us as requested. They are also allowed to apply for the ARPA Housing. Matt Obert makes a motion to cut the check for Recovery Anonymous. Bob Reich seconded the motion. Motion passed.
