Structures of this type, even though mounted on permanent foundations, and with wheels, tongue and hitch removed, are considered as portable "Trailer Coaches" or "Mobile Homes" or "Double Wide Homes" and may not be used as a living unit within this subdivision.
- 2. "Planning" as it appears in the third line of Paragraph 7 of the original Restrictive Covenants is hereby deleted and the word "planting" is hereby inserted in lieu thereof.
- The word "sitelines" as appearing in the second and last sentence of Paragraph 14 of the original Restrictive Covenants is hereby deleted and the words "sight lines" is inserted in lieu thereof.
