OWNERS' CERTIFICATE

Glenn L. Fessler, Sabina Fessler, Gregory L. Fessler and John G. Fessler, being the legal owners of Lot 1 in Hook'n Quarter Subdivision, a Subdivision of a part of the Northeast Quarter of Section Twenty (20) in Township One (1) South of the Base Line, Range Seven (7) West of the Fourth Principal Meridian, in Adams County and in the State of Illinois; hereby provide that all conveyances of property hereafter made by the present or future owners of any of the lands included in the aforesaid subdivision shall be taken and understood as if incorporating in all such conveyances without repeating the same, the following additional amendment to the original Restrictive Covenants, this said Amendment having been signed by a majority of the lot owners in said subdivision, all of those who signed this amendment having agreed to the change.

AMENDMENT TO RESTRICTIONS AND COVENANTS

1. Paragraph 1 of the Restrictions and Covenants in the Original Restrictive Covenants filed October 26, 1977 in Book 84 of Miscellaneous, at page 1687, in the Office of the Recorder for Adams County, Illinois, shall apply to Lot One (1) in said subdivision except that the said Lot One (1) may be subdivided into two lots with the west 120 feet to become a separate lot from the remaining portion of Lot One (1) and as to the new lot created by dividing off the West 120 feet from Lot One (1), another building may be erected for residential purposes the same as if the said West 120 feet was a separate lot on the original plat of the said subdivision, and otherwise, paragraph 1 of the original Restrictions and Covenants shall remain in full force and effect, and the new lot consisting of the west 120 feet of the original Lot One (1), shall hereafter be numbered and designated as Lot One A (1A) of the Hook'n Quarter Subdivision and the remaining portion of Lot One (1) shall continue to be known as Lot One (1) of Hook'n Quarter Subdivision.


