This Amendment to Declaration (sometimes "Amendment") is made as of this Standard of OCTOBER, 1999 by James A. Stupavsky and Cheryl L. Stupavsky, husband and wife, (hereinafter sometimes referred to as the "Declarant") and at least four-fifths of the lot owners of Timberline, a Subdivision, (hereinafter sometimes referred to as "Timberline"), Timberline First Addition, a Subdivision (hereinafter sometimes referred to as "Timberline First Addition"), and Timberline Second Addition, a Subdivision (hereinafter sometimes referred to as "Timberline Second Addition");

WHEREAS, the Declarant and the undersigned Lot Owners, being at least four-fifths of the Lot Owners in all of the above named subdivisions, now desire to further amend the Restrictive Covenants as to all of the above named subdivisions,

NOW, THEREFORE, for good and valuable consideration, the Declarant and at least four-fifths of the said Lot Owners do hereby agree to amend the Restrictive Covenants by adding paragraph 10 to the said Amendment to Declaration as follows and it is hereby so amended:

"10. Parking On Public Streets. Motor vehicles, Boats, Boat trailers and other such wheeled devices and boats must be parked on private driveways or in garages of the Lot Owners and such shall not be parked on any of the public streets in any of the above named subdivisions and subsequent additions except temporarily and only if on-street parking is reasonably needed for gatherings at a Lot Owners' residence. Any such wheeled devices and boats parked in violation of this paragraph 10 may, upon direction of the Declarant and the Board of Directors of the Timberline Association be removed from the said street or streets and impounded until triple the amount of all costs of the removal and/or storage is paid in full to the Timberline Association."
