AMENDMENT TO PROTECTIVE COVENANTS

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, being the owners of the following described real estate:

Lots One (1) through Ten (10) in Northern Estates, a subdivision of a part of Lots 2 and 3 in Von Goerres Subdivision, a subdivision of part of the Northwest Quarter of Section 25 in Township 1 South of the Base Line, Range 9 West of the Fourth Principal Meridian, situated in the City of Quincy, County of Adams and State of Illinois,

The Protective Covenants are changed hereby and modified so that the owner of Lot Three (3) in Northern Estates Subdivision, the owner's heirs and assigns, shall have the right, and they are hereby granted the right, to use the premises for the erection and maintenance of a dwelling containing living space, excluding porches, breezeways, garages and basements, if any, of not less than 1400 square feet.

The Protective Covenants are changed further and hereby modified so that the owner of Lot Two (2) in Northern Estates Subdivision, the owner's heirs and assigns, shall have the right, and they are hereby granted the right, to construct a decorative fence which shall not exceed 6 feet in height to extend no nearer than the front line of any dwelling or the side line of any dwelling situated on said lot, the side of which is adjacent to a street, and which shall not exceed 4 feet in height from the front line of any dwelling or the side line of any dwelling situated on said lot to a point no closer than 3 feet to any street. Except for the modifications hereinabove provided, the Protective Covenants dated August 15, 1980 and recorded in Book 86 of Miscellaneous at Page 614, shall continue in full force and effect and the restrictions imposed thereon by the owners of the lots in Northern Estates Subdivision shall continue in full force and effect except as modified herein. No other amendment shall be binding unless the same is in writing and duly approved by the unanimous consent of the then existing owners of Lots One (1) through Ten (10) in Northern Estates Subdivision.
