- Ryan Hinkamper made a motion to approve payment of NGS Services, LLC invoice #1447 for 75% completion of the County Board Room sound system upgrade. Dave McCleary seconded the motion and it passed unanimously.
- Ryan Hinkamper made a motion to approve payment of NGS Services, LLC invoice #1448 for 50% completion of the County Board Room video system upgrade. Dave McCleary seconded the motion and it passed unanimously.
- David Hochgraber reported to the committee on the County website update.
- Joe Zanger made a motion to go into executive session for the discussion of legal matters. Dave McCleary seconded the motion and it passed unanimously.
- Les Post made a motion to go back into regular session. Ryan Hinkamper seconded the motion and it passed unanimously.
