WITNESSETH:

That they are the owners of the following described real estate, to-wit:

Crestmoor Subdivision, an Addition to the City of Quincy, being a Subdivision of part of the Northeast Quarter of Section Seven (7), in Township Two (2) South of the Base Line, in Range Eight (8) West of the Fourth Principal Meridian, situated in the County of Adams and State of Illinois,

that said owners hereby and herewith declare and covenant with each other and each and all subsequent owners of lots in said addition and grantees, lessees, assignees, devisees and heirs and all parties claiming by or through or under them, that the Restrictions Covering Crestmoor Subdivision filed in the Office of the Recorder of Deeds of Adams County, Illinois on January 17, 1972 in Book 83 of Miscellaneous records, at page 274 shall be null and void and of no force and effect and that the following provision contained in the Protective Covenants filed for record in the Office of the Recorder of Deeds of Adams County, Illinois on February 14, 1972 in Book 83 of Miscellaneous records, at page 303, to-wit:

"No one-story dwelling shall contain floor space, ex-cluding porches, breezeways, garages and basement, if any,
of less than 1400 square feet. All other dwellings shall
contain floor space, excluding porches, breezeways, garages
and basement, if any, of at least 1850 square feet, being a
minimum of 1400 square feet on the first floor and 450 square
feet on the second floor."

shall be deleted therefrom and of no further force and effect and in lieu thereof the following provision shall apply:

"No one-story dwelling shall contain floor space, excluding porches, breezeways, garages and basement, if any, of less than 1400 square feet. All other dwellings shall contain floor space, excluding porches, breezeways, garages and basement, if any, of at least 1850 square feet, being a minimum of 1100 square feet on the first floor and 750 square feet on the second floor."

That all other covenants contained in the Protective Covenants recorded in Book 83 of Miscellaneous records, at page 303 shall remain in full force and effect.
