AMENDMENT TO PROTECTIVE COVENANTS

THIS DECLARATION made this 13th day of November, A.D.
1968 by those persons whose signatures appear below,

W I T N E S S E T H:

That those persons whose signatures appear below and each and
all of them are owners of the following described real estate, to-wit:

Lots One (1) through Sixteen (16) inclusive of
Eastate Subdivision, a Subdivision of part of
the Southwest Quarter of the Southwest Quarter
of Section Two (2) and part of the Northwest
Quarter of the Northwest Quarter of Section
Eleven (11) in Township Two (2) South of the
Base Line, in Range Eight (8) West of the Fourth
Principal Meridian, situated in the County of
Adams and State of Illinois,

that said owners hereby and herewith declare and covenant with each
other and each and all subsequent owners of lots in said addition
and grantees, lessees, assignees, devisees and heirs and all parties
claiming by or through or under them, that the covenants contained
in the Protective Covenants dated July 16, 1963 and recorded in the
Office of the Recorder of Deeds of Adams County, Illinois on July 29,
1963 in Book 71 of Miscellaneous records, at page 376, be and the same
are hereby released as to said Lots One (1) through Sixteen (16)
inclusive of Eastate Subdivision and in lieu thereof the following
restrictions are adopted as to said Lots One (1) through Sixteen (16)
inclusive of Eastate Subdivision:

1. These covenants shall take effect immediately upon the recording
thereof and shall apply immediately to all of the above described real
estate.

2. These covenants shall run with the land and shall be binding
upon all the parties and persons claiming under them until January 1,
1972, at which time said covenants shall be automatically extended
for successive periods of ten (10) years unless by agreement of a
majority of the then owners of the above-described real estate or the
several lots and parcels thereof it is agreed to charge said covenants
in whole or in part. In determining the majority of the then owners,
each and every owner of a lot or parcel of real estate shall have an
equal right.

3. If the parties hereto or any of them or their heirs or assigns shall violate or attempt to violate any of the covenants herein contained, it shall be lawful for any other person or persons owning any lot or parcel of said real estate to prosecute any proceeding at law or in equity against the person or persons violating or attempting to violate any such covenant either to prevent him or them from so doing or to recover damages for such violation or violations.

4. The invalidation of any one of these covenants by judgment or order of any court of record shall in no wise affect any of the other provisions or covenants herein contained.

5. All platted lots except Lots 1 and 2, shall be known as residential lots and all buildings constructed thereon are to be used for residential purposes only and there shall be no more than one two family residence built on each lot except that any lot except Lots 14 and 15 may be redivided so as to increase the size of any lot or decrease the size of any lot, but no such lot shall be decreased in size to less than the average square feet contained in said residential lots, except that said lots may be used for public schools, elementary and high schools and educational institutions having a curriculum the same as ordinarily given in public schools and for purposes incidental thereto including the erection and maintenance of buildings and playground facilities. In no event shall Lot 14 be subdivided or decreased in size. Lots 1 and 2 shall be totally exempt from the provisions of this paragraph of these protective covenants. Lot 15 may be divided into 2 lots. All lots shall be kept neat and clean and the grass mowed.

6. No lot shall be used for other than residential purposes. No buildings shall be erected, altered, placed or permitted to remain on any lot except Lots 1 and 2, other than one detached single family dwelling or one two family dwelling not to exceed two stories in height and a private garage or garages for not more than two cars each.

7. All dwellings and garages shall be constructed of brick or stone including exposed or walk-out basement, and must be completed and have at least two coats of paint within one year from date of beginning construction and all driveways shall be either concrete or blacktop or gravel.

8. No fence or wall shall be erected, placed or altered on any lot nearer to any street than the minimum building set-back line and no more than four feet in height.

9. No dwelling shall be permitted on any lot at a cost of less than \$20,000.00 based upon cost levels prevailing on the date these covenants are recorded, it being the intention and purpose of the covenants to assure that all dwellings shall be of equality of workmanship and materials substantially the same or better than that which can be produced on the date these covenants are recorded at the minimum cost stated herein for the minimum permitted dwelling size.

10. No dwelling shall contain floor space, excluding porches, breezeways, garages and basement, if any, of less than 1200 square feet.

11. No building shall be located on any lot nearer to the front line or nearer to the side street line than the minimum set-back lines shown on the recorded plat. No dwelling shall be located nearer than

ten feet to an interior lot line. No dwelling or building shall be located on any interior lot nearer than ten feet to the rear lot line. For the purposes of those covenants, eaves, steps and open porches shall not be considered as a part of a building.

12. No clothes line post or non-ornamental fixture shall be located on any lot nearer to the front lot line or nearer to the side street line than the minimum set-back lines shown on the recorded plat nor located nearer than five feet to an interior lot line nor located on any interior lot nearer than ten feet to the rear lot line.

13. Easements for installation and maintenance of utilities and drainage facilities are reserved as shown on the recorded plat. Easements reserved on the recorded plat for any purpose whatsoever shall remain as permanent easements to the benefit of all parties owning lots or parcels of land in said above described tract of real estate and no permanent building or structures shall be erected on said premises.

14. No noxious or offensive activity shall be carried on upon any lot nor shall anything be done thereon which may be or may become an annoyance or nuisance to the neighborhood.

15. No structure of a temporary character, trailer, basement, tent, shack, garage, barn or other outbuilding shall be used on any lot at any time as a residence either temporarily or permanently.

16. No oil drilling, oil development operations, oil refining, quarrying or mining operations of any kind shall be permitted upon or in any lot, nor shall oil wells, tanks, tunnels, mineral excavations or shafts be permitted upon or in any lot. No derrick or other structure designed for use in boring for oil or natural gas shall be erected, maintained or permitted upon any lot.

17. No animals, livestock or poultry of any kind shall be raised, bred or kept on any lot, except that dogs, cats, ponies, riding horses or other household pets not to exceed two in number may be kept provided that they are not kept, bred or maintained for any commercial purpose.

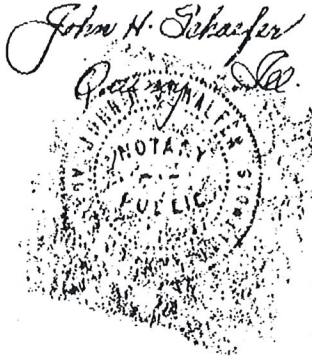
18. No lot shall be used or maintained as a dumping ground for rubbish. Trash, garbage or other waste shall be not kept except in sanitary containers. All incinerators or other equipment for the storage or disposal of such material shall be kept in a clean and sanitary condition.

19. No individual sewage disposal system shall be permitted on any lot unless such system is designed, located and constructed in accordance with the requirements, standards and recommendations of State of Illinois, Department of Public Health. Approval of such system as installed shall be obtained from such authority.

20. No fence, wall, hedge or shrub planting which obstructs sight lines at elevations between two and six feet above the roadways shall be placed or permitted to remain on any corner lot within the triangular area formed by the street property lines and a line connecting them at points 25 feet from the intersection of the street lines, or in the case of a rounded property corner from the intersection

of the street property lines extended. The same sight line limitations shall apply on any lot within 10 feet from the intersection of a street property line with the edge of a driveway pavement. No tree shall be permitted to remain within such distances of such intersections unless the foliage line is maintained at sufficient height to prevent obstruction of such sight lines.
