## PROTECTIVE COVENANTS

KNOW ALL MEN BY THESE PRESENTS, that we, Eugene J. Goerlich and Rita M. Goerlich, being the sole owners of the following described real estate:

Lots One (1) to Twenty-three (23), inclusive, in Stone Haven Subdivision, being a part of the Southeast Quarter of Section Seventeen (17), Township Two (2) South, Range Eight (8) West of the Fourth Principal Meridian, Adams County, Illinois,

do hereby make and establish the following Protective Covenants:

1. All lots shall be used as residential lots and any buildings erected upon said lots shall not be used for any other purpose other than providing a dwelling house, with the exception of Lots One (1), Two (2), Three (3), Four (4), Twenty-one (21), Twenty-two (22), and Twenty-three (23), which may be used for farm purposes or light commercial purposes.
2. All garages or other outbuildings constructed on the said lots shall conform in construction and appearance to the dwelling house constructed on such lot and shall be finished on the outside in material similar in appearance and construction to that of the main dwelling house.
3. No animals may be kept or raised on any of said lots, with the exception of Lot Four (4), for commercial purposes, provided, however, that any form of animal may be kept or raised on any of said lots as a pet, provided the owner of said pet gives said pet adequate care and treatment.
4. No structure of a temporary character, trailer, basement, tent, shack, garage, barn or other outbuilding shall be used on any lot at any time as a residence, either temporarily or permanently, and no house trailer or so-called double trailer, whether on a foundation or not, shall be placed on any lot any time.
5. All buildings constructed or to be erected on said lots shall conform to the building lines and easement lines as shown on the plat of said subdivision recorded in the Recorder's Office of Adams County, Illinois, in Book 13 of Plats at Page 362, and no dwelling house or other building shall be placed or constructed closer than 10 feet to any side lot line, provided, however, that any building or buildings now located on any of said lots shall not be subject to the provisions of this paragraph.
6. Any dwelling house which may be built on any of said lots shall be under permanent roof, and the exterior shall be completely finished within one year from the date the construction of said dwelling house is commenced. Construction of any garages or outbuildings must be completed within a reasonable time after said construction is commenced and no garage or outbuilding is to remain unfinished or in neglect of repair.

The erection of fences and hedges shall be limited to forty-eight inches in height and said fences shall be of open construction and be of neat appearance. All out-buildings shall conform in construction and appearance with the dwelling house.

7. Invalidation of any one of these covenants by judgment or Court order shall in no wise affect any of the other provisions which shall remain in full force and effect.

8. These covenants are to run with the land and shall be binding on all persons or parties claiming under them until January 1, 1970, at which time such covenants shall be automatically extended for periods of ten years, unless, at any time, by a vote of the majority of the lots hereinabove described, each lot having one vote, it is agreed to change said covenants in whole or in part.
