## PROTECTIVE COVENANTS

ENCW ALL MEN BY THESE PRESENTS, That We, Kenneth A. Bigelow and Bonnie L. Bigelow, husband and wife, being the owners of the hereinafter described real estate do hereby make and establish the following Protective Covenants which shall cover the following described
ing Protective Covenants which shall cover the following described
real estate, all situated in the County of Adams and State of Illinois,
to-wit:

Lots One (1) through Six (6) in Block One (1); Lots One (1) through Fourteen (14) in Block Two (2) in White Acres, being a Subdivision of part of the Northwest Guarter of Section Thirteen (13) in Township Two (2) South of the Base Line and in Eange Nine (9) West of the Fourth Principal in Eange Nine (9) West of the Fourth Principal Meridian, situated in the County of Adams and State of Illinois.

These covenants shall take effect immediately upon the recording thereof and shall apply immediately to all of the above descrobed real estate.

These covenants shall run with the land and shall be binding upon all the parties and persons claiming under them until January 1, 1965, at which time said covenants shall be automatically extended for successive periods of five (5) years unless by agreement of the them owners of the above described real estate or the several lots and parcels thereof it is agreed to change said covenants in whole or in part. In determining the majority of the them owners, each and every owner of a lot or parcel of real estate shall have an equal right.

shall violate or attempt to violate any of them or their heirs or assigns that violate or attempt to violate any of the covenants herein contained, it shall be lawful for any other person or persons owning any lot or parcel of said real estate to prosecute any proceeding at law or in equity against the person or persons violating or attempting to violate any such covenant either to prevent him or them from so doing or to recover damages for such violation or violations.

The invalidation of any one of these covenants by judgment or order of any court of record shall in no wise affect any of the other provisions or covenants herein contained.

NUISANCES No noxious or offensive activity shall be carried on upon any lot, nor shall anything be done thereon which may be or may become an annoyance or nui sance to the neighborhood.

TEMPORARY STRUCTURES No structure of a temporary character, trailer, basement, tent, shack, garage, barn or other outbuilding shall be used on any lot at any time as a residence either temporarily or permanently.

SIGNS No sign of any kind shall be displayed to the public view on any lot except one professional sign of not more than one square foot, one sign of not more than five square feet advertising the property during the construction and sales period.

OIL AND MINING OPERATIONS No oil drilling, oil development operations, oil refining, quarrying or mining operations of any kind shall be permitted upon or in any lot, nor shall oil wells, tanks, tunnels, mineral excavations or shafts be permitted upon or in any lot. No derrick or other structure designed for use in boring for oil or natural gas shall be erected, maintained or permitted upon any lot.

LIVESTOCK AND POULTRY No animals, livestock or poultry of any kind shall be raised, bred or kept on any lot, except that dogs, cats, or other household pets may be kept provided that they are not kept, bred or maintained for any commercial purposes.

GARBAGE AND REFUSE DISPOSAL No lot shall be used or maintained as a dumping ground for rubbish. Trash, garbage or other wastes shall not be kept except in sanitary containers. All incinerators or other equipment for the storage or disposal or such material shall be kept in a clear and sanitary condition.

SEWAGE DISPOSAL No individual sewage disposal system shall be permitted on any lot unless such system is designed, located and constructed in accordance with the requirements, standards and recommendations of State of Illinois, Department of Public Health. Approval of such system as installed shall be obtained from such authority.

SIGN DISTANCE AT INTERSECTION No fence, wall, hedge or shrub planting which obstructs sight lines at elevations between two and six feet above the roadways shall be placed on permitted to remain on any corner lot within the triangular area formed by the street property

lines and a line connecting them at points twenty-five (25) feet from the intersection of the street lines, or in the case of a rounded property corner from the intersection of the street property lines extended. The same sight line limitations shall apply on any lot within ten (10) feet from the intersection of a street property line with the edge of a driveway pavement. No tree shall be permitted to remain within such distances of such intersections unless the foliage line is maintained at sufficient heighth to prevent obstruction of such sight lines.

All platted lots shall be known as residential lots and all buildings constructed thereon are to be used for residential purposes only and there shall be no more than one residence built on each lot except that said lots may be redivided so as to increase the size of any lot or decrease the size of any lot, but no lot shall be decreased in size to less than the average square feet contained in said residential lots, except that said lots may be used for public schools, elementary and high schools and educational institutions having a curruculum the same as ordinarily given in public schools and for purposes incidental thereto including the erection and maintenance of buildings and playground facilities.

LAND USE AND BUILDING TYPE No lot shall be used for other than residential purposes, except as hereinbefore provided. No buildings shall be erected, altered, placed or permitted to remain on any lot other than one detached single family dwelling not to exceed two stories in heighth and a private garage for not more than three cars.

All dwellings and garages must be completed and have at least two coats of paint within one year from date of beginning construction.

No fence or wall shall be erected, placed or altered on any lot nearer to any street than the minimum building setback line and no more than four (4) feet in heighth.

DWELLING, QUALITY AND SIZE No dwelling shall be permitted on any lot at a cost of less than \$25,000.00 based upon cost levels pre-

than that which can be produced on the date these covenants are recorded at the minimum cost stated herein for the minimum permitted dwelling size.

No dwelling shall contain floor space, excluding porches, breezeways, garages and basement, if any, of less than 1000 square feet.

BUILDING LOCATION No building shall be located on any lot nearer to the front lot line or nearer to the side street line than the minimum setback lines shown on the recorded plat. No dwelling shall be located nearer than five (5) feet to an interior lot line. No dwelling or building shall be located on any interior lot nearer than ten (10) feet to the rear lot line. For the purpose of those covenants eaves, steps and open porches shall not be considered as a part of a building.

EASEMENTS Easements for installation and maintenance of utilities and drainage facilities are reserved as shown on the recorded plat. Easements reserved on the recorded plat for any purpose whatsoever shall remain as permanent easements to the benefit of all the parties owning lots or parcels of land in said above described tract of real estate and no permanent building or atructures shall be erected on said premises.
